I. Project Overview

The Maplewood Richmond Heights School District (MRH) is seeking proposals for upgrading the lighting system at our soccer and track field located at 7500 Lohmeyer Ave, Maplewood, MO. This project aims to install a reliable, energy-efficient LED lighting system that guarantees 50 foot-candles across the entire athletic surface, ensuring optimal illumination for all track and field and soccer events.

All vendors must submit two proposals:

- 1. **Primary Proposal:** A base LED system that guarantees 50 foot-candles across the entire playing and track surface.
- 2. Alternate Proposal: An upgraded LED system that meets the same lighting guarantees as the base proposal but includes full RGB lighting functionality across the field and track for color effects and event customization. B. Relocate driver access panels to the base of each pole, no higher than 20 feet. A and B should be specifically provided as separate breakout items on your final bid.

II. Project Goals

- **Guaranteed Lighting Levels:** Achieve consistent 50 foot-candles across the entire soccer and track field.
- LED Technology Upgrade: Improve energy efficiency and reduce long-term operational costs.

- **Limit Fixture Reuse:** Modernize infrastructure by minimizing the reuse of outdated fixtures.
- Modern Controls: Integrate remote and scheduled control via mobile/desktop platforms.
- Operational Simplicity: Include easy on/off functionality.
- Enhanced Visibility and Safety: Ensure proper visibility and a safe environment for all users.

III. Scope of Work

- Evaluate existing infrastructure and recommend an efficient upgrade strategy.
- Retrofit or Provide and install new LED lighting fixtures and integrated control systems.
- Provide all materials, labor, conduit, permits, wiring, and disposal.
- Conduct a minimum of two nighttime aiming and calibration sessions.
- Provide at least 2 hours of technical training for MRHSD technology staff and 2 hours of user training. All sessions must be recorded and provided to the owner.
- Submit final drawings, submittals, as-built drawings, warranties, O&M manuals, and a recommended spare parts list.
- Coordinate lighting installation with any ongoing track and fieldwork.
- Provide post-installation support, including a 9-month warranty walk.

IV. Requirements

- Guaranteed 50 foot-candle lighting coverage across the entire playing surface.
- Modern LED fixtures meeting NEC, IES, and local code standards.
- Programmable control system (wireless preferred; mobile/desktop compatible).
- Any reuse of existing fixtures must be justified.
- All contractors must comply with prevailing wage laws. We have previous quality experience with Kammerlen, Legacy, Schaeffer, and Kaybee.
- Submit current insurance, licenses, and certifications.

- Warranty information for all systems.
- **Two pricing proposals:** Base bid and RGB alternate (separate sheet)
- Three references from similar athletic lighting projects.
- Electrical contractor name and credentials.
- Any contractors being used that are within MRH School District or belong to the Mid County Chamber of Commerce.

- Cost-effectiveness and long-term value.
